I. TITLE:

PROVISION OF FUEL THROUGH THE USE OF FLEET CARDS FOR CY 2020

II. APPROVED BUDGET FOR THE CONTRACT (ABC):

One Hundred Eight Thousand Pesos (Php 108,000.00)

III. CONTRACT DURATION

The contract shall start Seven (7) calendar days upon conforme of Work Order (WO) up until December 31, 2020

IV. OBJECTIVES

- 1. To ensure availability and supply of the fuel requirements of the vehicles for four (4) months;
- 2. To be able to access the supply of fuel in service stations nationwide;
- 3. To effectively and efficiently manage the fuel consumption of the BAFE motor vehicles;

V. SCOPE OF THE CONTRACT

1. Availability in the provision of the fuel requirements based on the estimated volume/quantity of allocation; as follows:

- 2. If necessary, as approved by designated BAFE Official (s), revise and amend the list of BAFE authorized vehicles for the supply of fuel;
- 3. Utilization of fuel shall be through use of fleet cards.

VI. SUPPLY OF FUEL

The contractor shall ensure the availability and supply of fuel at any authorized gasoline/service station nationwide through the use of fleet cards.

VII. RESPONSIBILITIES OF THE SUPPLIER

- 1. The supplier shall assume overall responsibility for the quality, availability and continuous nationwide supply of fuel to BAFE service vehicle;
- The supplier shall issue fleet cards, under the name of DA Bureau of Agricultural and Fisheries Engineering (BAFE) to all BAFE motor vehicles;
- The supplier shall ensure the availability and supply of fuel at any authorized gasoline station nationwide through the use of fleet cards.

VIII. TERMS OF GUARANTEE

- The supplier shall protect the DA-BAFE from possible frauds, misuse and abuse of the fleet cards;
- The supplier shall provide individual fleet cards to each motor vehicle to identify BAFE motor vehicle that are allowed to refuel;
- The supplier shall provide mechanisms to limit the refueling up to the maximum allowable monthly allocation per vehicle/fleet card;
- The supplier shall guarantee the availability of gasoline stations nationwide;
- The supplier shall ensure online access for every transaction;
- 6. The supplier shall issue official receipts for every transactions made;
- The supplier shall guarantee 24/7 accessibility for complaints, queries or report of loss fleet cards.

IX. MINIMUM REQUIREMENTS

The supplier shall establish the capacity to fulfill the aforementioned responsibilities by submitting the following:

- 1. Documentary proof of existing institutional clients;
- 2. List and locations of gasoline stations;
- 3. Company Profile: and
