#### TECHNICAL SPECIFICATIONS

SUPPLY AND DELIVERY OF FOUR (4) UNITS BRAND NEW AIR-CONDITIONED MOTOR VEHICLES FOR THE BUREAU OF AGRICULTURAL AND FISHERIES ENGINEERING (BAFE)

### I. BACKGROUND


In compliance with the Republic Act. No. 9184 known as the "Government Procurement Reform Act", the BAFE will be conducting a public bidding for the supply and delivery of four (4) unit brand new air-conditioned motor vehicles. The procurement of vehicle is in support of the performance of various field activities such as validation of proposed projects under the National FMR Network Plan and monitoring of the physical progress of FMR funded projects. Moreover, this activity will help in achieving the 8-socio-economic agenda of the President, in particular, food security, transport, and logistics. Likewise, it will contribute to the realization of the Philippine Development Plan (PDP) 2023-2028 targets, specifically Chapter 3.1 (Ensure Food Security and Proper Nutrition), Chapter 5 (Modernize Agriculture and Agribusiness), and Chapter 12 (Expand and Upgrade Infrastructure). Lastly, this also coincides with the Joint Administrative No.1, Series of 2023 (Formulation, Implementation, and Updating of the National Network of FMRs 2023-2028).

### II. OBJECTIVES

- 1. For mobility of BAFE personnel to conduct field validation, monitoring, and evaluation, and attend to official functions to and from various official destinations.
- 2. To ensure more efficient delivery of quality services to DA clients and other relevant stakeholders through an adequate motor transport system.

### III. APPROVED BUDGET FOR THE CONTRACT (ABC):

The Approved Budget for the Contract is Nine Million Eight Hundred Thirty-Two Thousand Five Hundred Pesos (Php9,832,500.00). Seven Million Fifty Thousand Pesos (Php7,050,00.00) is allocated for the three (3) units of Pick-up Truck while Two Million Seven Hundred Eighty-Two Thousand Five Hundred Pesos (Php2,782,500.00) is for the one (1) unit Passenger Van, inclusive of all taxes, testing, and delivery.

## IV. BIDDER'S QUALIFICATIONS

The eligibility of the prospective bidders shall be based on the submission of the documents enumerated in the bidding documents, among which, is a valid and current mayor's permit/municipal license as stipulated in Section 23.6 of the IRR-A of R.A. 9184. Likewise, additional requirement is the Certification from the Land Transportation Office (LTO) - accredited manufacturers and importers attesting to the availability of authorized dealers and service centers within the Philippines for the last twenty (20) years.

#### V. DELIVERABLES

A total of four (4) units brand-new air-conditioned motor vehicles with technical specifications stipulated in Item No. VI shall be delivered to BAFE: i) Three (3) units of Pick-up Truck, and ii) One (1) unit of Passenger Van. The pick-up truck shall be a four-wheel enclosed vehicle intended for conveying passengers and/or hauling cargo, traditionally having four (4) doors (two side doors for the driver and front passengers) and seating capacity is good for at least 5 passengers, including the driver. The passenger van, on the other hand, shall be a large four-wheel enclosed vehicle intended for conveying passengers and/or hauling cargo, traditionally having four (4) doors (two side doors for the driver and front passengers, a passenger side sliding door, and tailgate). The seating capacity ranges from 12 to 15 passengers, including the driver.

## VII. OTHER REQUIREMENTS

- 1. Warranty Three (3) years or 100,000 kilometers whichever comes first.
- 2. Three (3) years LTO Registration.
- 3. One (1) year GSIS Third-Party Liability motor vehicle insurance.
- 4. One (1) year GSIS Comprehensive motor vehicle insurance.
- 5. Free labor on preventive maintenance service for the first one thousand (1,000) and five thousand (5,000) kilometers.
- 6. Dealers must have service centers in Metro Manila and nearby provinces (Bulacan, Cavite, Laguna and Rizal).
- 7. AFTER-SALES SERVICE
  - a. Submission of Certificate of After Sales Service, Manpower Requirements, and Availability of spare parts within the warranty period with the list of accredited service centers in the Philippines, indicating the address, telephone numbers, and contact persons.
  - b. Certificate of undertaking that spare parts shall be available 10 years from the date of acceptance.
- 8. Original Warranty/Guarantee Certificates shall be issued in the name of BAFE.
- 9. Distributorship Agreement shall be provided for the legitimacy of the supplier.
- 10. Dealers must submit recent government or private customer service experience/satisfaction from their office.
- 11. In the observance of COA Circular 1977-061: Provision of "For Official Use Only" marking with the name of the office using it and the clear-cut logo of the agency, on each side of the motor Vehicle (see attached picture).

### VIII. DELIVERY SCHEDULE

- 1. Delivery Period: The Four (4) unit brand new air-conditioned motor vehicles must be delivered within **thirty (30) calendar days** upon the receipt of the Notice to Proceed (NTP).
- 2. Delivery Site: The motor vehicle must be delivered at the address below:

- 2. The DA-BAFE shall have the right to reject and return the unit and cancel the corresponding Contract if units delivered are defective, incomplete or non-compliant to the specifications herein specified.
- 3. All costs of testing shall be for the account of the supplier.

The payment shall be done within thirty (30) calendar days upon receipt, inspection and acceptance of the vehicle including documents such as Motor Vehicle Official Receipt and Certificate of Registration.
