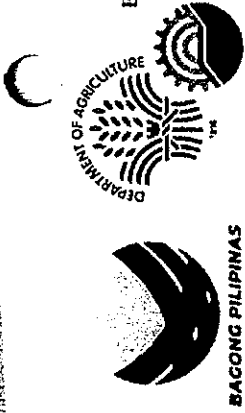
Thank you for your understanding, and I hope we can explore future opportunities once the required resources and conditions are in place.
