

The BAFE Internal TWG shall have the following responsibilities:

- 1. Develop and review the project concept note;
- Prepare maps based on the submitted shapefiles and plans from DPWH, NIA, and BSWM:
- 3. Prepare the detailed program of works, including budget and resource plans, and a detailed engineering designs of the project;
- 4. Prepare/Review feasibility study of the project; and
- 5. Attend and participate in the meetings, workshops and other activities in the planning, implementation and monitoring of the project including coordination with the other concerned agency such as the DPWH, NIA, and BSWM.

The expenses to be incurred in the performance of the duties and responsibilities shall be charged to the funds allocated to BAFE, subject to and in accordance with the existing government accounting and auditing rules and regulations.

This order shall take effect immediately and shall remain in force unless revoked in writing. All orders, memoranda, and issuances inconsistent herewith are deemed revoked.
